Meeting Minutes

- **Treasurer Report:** Balance on 12/30 - \$31,425.69; 4 debits \$9274.79 (2 from Holiday Party and 2 from Spook and Sip); Current balance 1/31 \$22,150.90
If you have any gift cards used from the Spook and Sip, please give to Pat ASAP.
- **Website Update** – Ryan Chilson reported that analytics were not turned on so we have no insight to traffic on our DBA website until now. Each business is responsible for our own content, upcoming events, etc. We just log into the portal and tell Chris what we need fixed and they will fix it. Cost for them hosting is \$325 for 3 hrs of updates, including maintenance/hosting fees. These 3 hours each month can roll forward if we do not use them. **Chris will be at our March Meeting to review with us how to update our information on the portal so bring a device with you to our March Meeting.**
- **By-Laws, Elections** – 2023 -2024 Elect a President Elect and Treasurer (The Board has suggested Debbie remains as president one more year)
2024-2025 President Elect becomes President – Elect New Secretary (Debbie becomes past president – Kim no longer in past president role)
2025-2026 President second year – Elect President Elect and Treasurer
2026-2027 President Elect becomes President. Elect a new Secretary. Current President becomes Past President

Pat discussed the Treasurer Job Description and will properly train the new Treasurer. LeAnna, from Papillion Eagles, nominated herself as a candidate for Treasurer.

- **Spring Open House Posters/Cards** – March 17 & 18 – Posters were distributed to participating businesses and others to be displayed. If you were not at the meeting and are participating, please stop by Kajoma's for your poster and handouts.
- **Summer Sip and Walk** – Date is June 2, 2023 – The attendees put a motion and all voted in favor to attempt to set up the Sip and Walk the following way: A list of Breweries, Distilleries and Wineries were presented to the group last night and we divided them up upon us to go speak to them or call them and ask them to be a vendor at a stop on the Sip and Walk. They will be responsible for delivering and serving their beverages and obtaining an SDL, which DBA will reimburse them for along with the consumed beverages.
